

Important read carefully Conditions of Entry

**You accept these Conditions of Entry by entering or using the GTO Facilities area.
If you do not accept these Conditions of Entry you must not enter.**

1. You may only enter and use the GTO Facility if:
 - a. you have a pre booked passenger and you have executed the Commercial Ground Transport Operator Licence with Brisbane Airport Corporation Pty Ltd ('Agreement'); or
 - b. Brisbane Airport Corporation Pty Ltd ('BAC') has given prior written approval to do so.
2. If you have executed a Licence Agreement then the terms of that Agreement apply.
3. If you have prior written approval from BAC to enter the GTO Facility Area then the following Conditions of Entry apply.
4. **If you have not executed a Licence Agreement or You do not have prior written approval from BAC, you are not authorised to enter the GTO Facility and you must leave immediately. Whilst you are present in the GTO Facility the following Conditions of Entry apply.**
5. You acknowledge and agree that the boom gates will only open for entry and exit of a GTO Facility if a valid electronic tag is read and accepted by the electronic tag reader.
6. You are responsible for ensuring that the electronic tag:
 - a. can be read by the electronic tag reader on entry and exit;
 - b. is registered with BAC; and
 - c. the account attached to the electronic tag has sufficient funds to cover the applicable fee.
7. Without limiting any other right or remedy of BAC, You indemnify BAC against:
 - (a) any liability to or claim by a third party (including Your Associates); and
 - (b) all costs, expenses (including those payable to consultants, lawyers and other advisors), fines, penalties, losses and damages suffered or incurred by BAC,arising directly or indirectly out of or in connection with Your use of the GTO Facility.
8. To the full extent permitted by law, You release BAC from liability for any claim in respect of or arising from:
 - (a) damage or injury to any person or property in the GTO Facility, Terminals or the Airport;
 - (b) a Service being interrupted or malfunctioning;except to the extent that a negligent act or omission or wilful default of BAC or its employees or agents contributed to the claim.
9. To the full extent permitted by law:
 - (a) You occupy and use the GTO Facility, Terminals and the Airport at Your own risk; and
 - (b) BAC will not be liable to the Operator or any other person for any reason howsoever caused whether in contract, tort, equity or otherwise for any of the following indirect, special, economic or consequential loss or damage, loss of revenue, time, goodwill, data, profits, anticipated savings or opportunity.
10. You acknowledge and agree that BAC assumes no duty of care (other than any duties prescribed by law) to maintain security in relation to the GTO Facility or verify the bona fides of any person entering, or in control of, any vehicle.

11. You must pay the applicable fees for use of the GTO Facilities.
12. You must not stop or park in a disabled parking zone unless the Vehicle displays a current parking permit for people with disabilities or prior written approval has been granted by BAC to assist disabled passengers.
13. BAC may move or remove a Vehicle for operational or safety reasons or if the Vehicle is parked in an unauthorised spot. You agree to pay any reasonable costs incurred by BAC in moving or removing (as the case may be) your Vehicle.
14. Access is subject to BAC's directions at all times and all users of the GTO Facilities must comply with all signs and direction markings displayed in the GTO Facility.
15. The Australian Road Rules and the Airports (Control of On-Airport Activities) Regulations 1997 apply and are enforced at Brisbane Airport. Fines are payable for non-compliance.
16. These Conditions of Entry are subject to the laws of Queensland, Australia and you submit to the non-exclusive jurisdiction of the courts of Queensland situated in Brisbane.
17. For the purpose of these conditions "**GTO Facility**" means the terminal access roads which have been designated for ground transport operators' (bus, taxi, courtesy vehicle or limousine) passenger drop off and collection zones by BAC and all designated holding areas, including but not limited to the central parking area.
