

# **ACHIEVEMENTS**

#### **COMMUNITY CONSULTATION**

The BACACG continued to facilitate direct access for community members to Airservices Australia and airline representatives, driving collaboration and understanding of the complexities of aviation operations and how these impact the community.

The BACACG also provides an opportunity for special interest groups to engage directly with BAC and the broader airport community on issues which they deem important. The Brisbane Airport Bicycle Users and Pedestrians Group (BUG) attended and briefed a number of BACACG meetings on their interest in greater investment in bicycle and pedestrian facilities at the airport. This has resulted in a closer and mutually beneficial relationship between the BUG and BAC bringing about better bicycle and pedestrian outcomes in road and access design for the airport precinct.

## BRISBANE'S NEW RUNWAY DEVELOPMENT

BAC provided regular updates to the BACACG on the progress of the new runway at Brisbane Airport. These updates play an important role in ensuring BAC is aware of any particular community concerns in relation to the project, particularly with regard to design and construction. The BACACG will continue to play a key role in the community engagement process, providing BAC and Airservices Australia with essential feedback on its communications plans and strategies for the broader community.

#### SITE TOURS

In 2016, the BACACG held a meeting at Aviation Australia, a leading training provider for the aviation and aerospace industry. As part of the meeting, members of the BACACG toured the campus to see first-hand the skills future cabin crew and mechanical engineers are gaining.

Following the final meeting of 2016, the BACACG had the opportunity to tour the Airservices Australia Air Traffic Control tower. From the control room members could see the air traffic management operations at Brisbane Airport and gained a greater understanding of the operations and work environment of Brisbane's Air Traffic Controllers.




