- Jessica Shannon noted to the committee she has had ongoing correspondence with Mr King acknowledging BAC had no short term plans to put a childrens play area in the Domestic Terminal but an additional playspace at the International Terminal on Level 4 check in had been created.
- Mr King was directed to make a submission to the Master Plan during the Public Comment Period and this had been received.
- Mr King was informed if the demand changes, a children's play area or a children's space would be considered.

**Presentation from Bowman resident**

Steve Muller

*(see attached letter)*

- Mr Muller has lived in Belmont for many years and purchase a property immediately.
- Local Member was very vocal about where flights paths would be and not a lot of response was received at the time.
- Mr Muller then purchased a property and the Airport was opened one or two years after.
- There were complaints on the existing flightpath tracks, down from Creek Road on Runway 19 coming over this area.
- The flight path was then changed and there was no communication to residents.
- Mr Muller has lived in this area for the next 30 years and he is now retired and moved to Birkdale and has revisited the flight paths again.
- Mr Muller reiterates that flight paths should not be changed. Residents are now making serious decisions about moving at a large expense.
- ASA to provide a document on the reasons behind flight approaches, aircraft changes and the reasons was flight paths have to be adjusted. This document details the whole process of what is involved, stakeholder engagement and the consultation process (35-page document, very detailed) - **ACTION**
- ASA confirm that the level of consultation is dependant on the level of changes made and that back in the 1980's, the process of consultation was not as thorough.
- Ms Narelle Bell concedes that very good points have been raised by Mr Muller and the effectiveness of community engagement and its importance cannot be underestimated.  
Mr Muller asks why aircraft are turning back directly after going around Mud Island and coming back over Birkdale and Cleveland area and why can't they go over towards Moreton Island further and be over 13,000 ft when come back over the suburbs
- Also questioned is why BACACG has no representative for Bowman – **ACTION** – Jessica Shannon to speak with Chair.

**Airservices Australia update**

- From May 2020, ASA will make changes to flight planning requirements for aircraft arriving to Gold Coast Airport from northern ports.
  - Communities including Victoria Point, Cleveland, Thornlands, Russell Island, Coochiemudlo Island, Dunwich (North Stradbroke Island) and Macleay Island, currently see and hear up to seven jet aircraft on a busy day arriving from the north and west to Gold Coast Airport.
-

- These aircraft track on a concentrated flight path from overhead Brisbane Airport to the ESTER flight planning waypoint, and then on to Gold Coast Airport.
- Following the change, a small number of aircraft from locations including Asia, Cairns and Rockhampton will also operate on this flight path, resulting in a total of ten jet aircraft arrivals on a busy day.
